Peddler shall include any person who travels from place to place within the city, foot or other conveyance, selling for profit or offering for sale any goods, wares or merchandise and rendering immediate delivery thereof. **Hours: 9:00 a.m. – 5:00 p.m.**

Solicitors shall mean any person:

(1) Seeking to obtain order for the purchase of goods, wares, merchandise, foodstuffs, services of any kind, character or description whatever, for any kind of consideration whatever; (2) Seeking to obtain prospective customers for application or purchase or insurance of any type, kind or character; (3) Seeking to obtain subscriptions to books, magazines, periodicals, newspapers and every other type or kind of publication; or (4) Seeking to obtain gifts or contributions of money, clothing or any other valuable thing for the support or benefit of any charitable or nonprofit association, organization, corporation or project. **Hours: 9:00 a.m. – 5:00 p.m.**
